Ref: Combined Higher Secondary Level (10+2) Examination, 2019.

Based on the results of Combined Higher Secondary Level Examination 2019, declared by Staff Selection Commission, your name has been sponsored for appointment as Postal Assistant/Sorting Assistant in Department of Posts, in Level 4 in the Pay matrix. Subsequently, the Director General, Department of Posts, New Delhi 110001, has allotted you to Assam Postal Circle as per your merit and preference of circle, for taking further action for completion of other procedural requirements.

2. A candidate will be allotted to any one cadre amongst the following cadres only.

Note:

1. Posts reserved for PH and Ex Serviceman category are parts of total vacancies
2. Cadre once allotted will be final and is not interchangeable / transferrable afterwards.
3. Important notes for candidates:

(a) Postal Assistant in Circle/Regional offices, PA (CO/RO) posts are located at **Guwahati** and **Dibrugarh** and are transferable. However, posting of selected candidate will be subject to Administrative exigency and availability of vacancy.

(b) Postal Assistants in Post offices, PA (PO) cadre posts and Sorting Assistants (SA) in Railway Mail Service are Divisional level posts located in offices covering the respective Postal/RMS divisional jurisdiction. To enable the candidates to decide the order of preference of divisions, category-wise vacancies available in different divisions of the circle is indicated in Annexure-I.

(c) Postal Assistant in Savings Bank Control Organization PA (SBCO) posts are Circle cadre transferrable posts located in all the Head Post Offices in the entire Assam Postal Circle. However, posting of selected candidates will be to any Head Post Office in Assam subject to Administrative exigencies and availability of vacancy in that particular Head Post Office at the discretion of the competent authority.

4. A candidate shall be allocated the cadre and division on the basis of her/his merit(rank), order of preference(option) and vacancy available at her/his turn in the category she/he has been selected.

5. (a) Therefore all the selected candidates who are allotted to Assam Postal Circle are requested to indicate their preference of cadre in the enclosed option letter (**Annexure-II**) in the space provided at A.

Note: A candidate should indicate her/his option/order of preference for all 4 cadres

(b) Further, candidates are also requested to indicate their preference of divisions in the selected cadres in the option letter in the space provided at B (**Annexure-II**)

Note: A Candidate should indicate her/his option/order of preference for all divisions /units in all the cadres.

6. (a) Person with disability(PWD) candidate irrespective of the ranks will be allocated cadre and division first followed by Ex-Serviceman candidates as per the vacancy available.

(b) After allocation of cadres and divisions to PWD candidates and Ex Serviceman candidates, remaining candidates will be allocated cadres and division/units in the manner mentioned at para 4 above.


(c) Such candidates who are not able to get allocation in any of the post of her/his preference because of her/his preference might be allocated to the post/division where the vacancies exist at the discretion of the competent authority.

- (d) All such candidates who do not give any order of preference shall be allocated cadres and divisions subject to availability of vacancy in the category she/he has been selected after allocation of posts to all other candidates **at the discretion of the competent authority which will be final.**

7.(a) The duly filled in option form (**Annexure-II**) may be sent by email at apmgstaffghy@gmail.com or staff.as@indiapost.gov.in (followed by hard copy) on or before 03.10.2022 failing which it would be presumed that he/she has no preference for cadre/Division.

(b) Order of preference received after 03.10.2022 shall not be taken into account for consideration for allotment of cadre/division.
