The appointing authorities are requested to carry out all the required preappointment formalities as provided in relevant rules and instructions issued from time-to-time on the subject as applicable. Also, the Divisional/Unit Heads are requested to re-check the pre-requisite conditions prescribed for candidates, with reference to their recommendations while forwarding the forms of the applicants.
9. Before appointment, it should be ensured that, no disciplinary /vigilance case is pending or contemplated, or punishment is current against the selected/allotted candidates. If any, suitable action may be taken and such case should be referred to this office immediately through proper channel.
