3. The selection of candidates has been made as per revised procedure circulated vide Directorate's memo no. 17-08/2018-SPN-I dated 18.10.2023.

4. The selected candidates in Annexure-A & B are subject to fulfillment of the conditions mentioned in Notification of examination and relevant Recruitment Rules Amended from time to time.

5. It is personal responsibility of the Appointing Authorities to carry out verification of valid documents i.e. Date of Birth poof, educational qualification certificates, category (SC/ST/OBC/EWS) certificates and other eligibility conditions for respective vacancy year, as per ruling on the subject before issuing provisional appointment orders to the selected candidates.

6. In case, at any time, if it is detected that the candidate so selected had applied and appeared the examination with false declaration relating to educational qualification, category, length of service and physical disability etc. his/her selection will be cancelled without any notice.

If it is later noticed that the permission granted to any candidate to appear for the examination was not valid due to one or the other reasons, as per the orders on the subject, the candidature will be cancelled without any notice and his/her name will be removed from the list of successful candidates at any stage.

The appointing authorities are requested to carry out all the required pre-appointment formalities as provided in relevant rules and instructions issued from time-to-time on the subject as applicable. Also, the Divisional/Unit Heads are requested to re-check the pre-requisite conditions prescribed for candidates, with reference to their recommendations while forwarding the forms of the applicants.

9. Before appointment, it should be ensured that, no disciplinary /vigilance case is pending or contemplated, or punishment is current against the selected/allotted candidates. If any, suitable action may be taken and such case should be referred to this office immediately through proper channel.
