Sub: Engagement of GDS on Compassionate Ground.

This is regarding meeting on Review Committee for Compassionate Engagement(CCE) of GDS on Compassionate Ground which was held on 16th April, 2024. A total of 42 (Forty Two) cases were placed before the committee which are enclosed as **Annexure A**.

The Chief Postmaster General, Assam Circle, Guwahati is pleased to accept and approve 21(Twenty One) cases enclosed as **Annexure B** for engagement as Gramin Dak Sevaks (GDS) on compassionate ground under relaxation of normal rules.

The engagement, however will be subject to further verification of their fulfilment of eligibility criteria(s) from the original records to be verified by the Appointing Authority. Accordingly, the recommended candidates will be required to produce original certificates for educational qualification, date of birth etc. which should be verified by the appointing authority regarding their genuineness before appointing them. Verification of the genuiness of relevant testimonials is mandatory.

20 (Twenty) cases which were rejected by the CCE is enclosed as **Annexure C** for information. The Divisional Heads are requested to arrange for intimating the candidates accordingly at the earliest.

The case of Shri Maneswar Mushahary, S/O Shri Tikendra Musahary, Ex GDS MD, Gossaigaon SO who retired from service on medical invalidation on 02.09.2015 has been recommended for referral to Directorate for clarification.

The selection of candidates for engagement of the dependents of GDS are subject to the following conditions:

1. No material fact that would adversely affect their selection on relaxation ground is suppressed by the candidates in the synposis submitted by them.

2. The selection can be cancelled at any time if any error is detected in the information supplied by them which has aided their selection.

3. If any error is detected after the candidate is engaged as GDS on relaxation ground, the engagement will be terminated forthwith.

- 4. The candidates on their engagement as GDS will take care of the family members of the deceased GDS. A declaration to this effect has to be obtained and kept on
- 5. The approved candidates will submit required certificates on basic computer training before their engagement to the concerned units.
- 6. The engagement of the candidates is subject to satisfactory verification of the certificates/documents submitted by the applicant.

It is requested to communicate the decision of the committee to the selected candidates and take further necessary action at your end for engagement of the above candidates selected for GDS following all formalities within a fortnight and date of engagement may please be intimated to this office accordingly.
